

RICHMOND CITY CORPORATION
ORDINANCE 2006-1

WHEREAS the City of Richmond bears the responsibility to do everything within reason to ensure the safety and comfort of the citizens of the City, and

WHEREAS a sound and reliable infrastructure is crucial to the maintenance of the City, and

WHEREAS construction standards have improved with the passage of time, and

WHEREAS a formal outline of construction standards has not been outlined by the City since 1978,

NOW THEREFORE the City Council of Richmond City, County of Cache, State of Utah, hereby adopts, passes, and publishes the following:

AN ORDINANCE ESTABLISHING A NEW PART 700 TO TITLE
9-000 ENTITLED "RICHMOND CITY MANUAL OF DESIGN AND
CONSTRUCTION STANDARDS" OF THE *CODE OF REVISED
ORDINANCES OF RICHMOND (1975, ADOPTED 1976)* .

9-700. Construction Standards.

9-701. All construction undertaken for Richmond City will follow the standards contained within the latest edition of the *Manual of Standard Specifications*, and the *Manual of Standard Plans* as approved and published under the auspices of the Utah Chapter of the American Public Works Association and the Utah Chapter of the Associated General Contractors of America supplemented by the *Richmond City Manual of Design and Construction Standards*.

9-702. Any and all construction undertaken by private developers, contractors, agents, or citizens which connects with, attaches to, or in any manner influences or will be influenced by Richmond City infrastructure will also be required comply with the standards contained within 9-701.

9-703. Failure to comply with said standards will constitute a Class A misdemeanor at minimum, and may be up-graded should the severity impose a condition of harm upon Richmond City or the citizens thereof.

Upon passage of this ordinance, paragraph 4 of Richmond City Ordinance 2000-3 dated the 18th day of July, 2000 is hereby declared historic. The Construction Standards designed by Bush and Gudgell, Inc. dated May, 1978 with any subsequent amendments are also hereby declared historic.
